Howard Bray provided support and connections to editors James Boylan, Jon Swan, and Spencer Klaw at the *Columbia Journalism*

Review, who encouraged research into the FBI-CIA-army suppression of the underground press. The Newspaper Guild backed my testimony on Capitol Hill against the CIA Information Act, and the Guild's Madison Press Connection sponsored my Freedom of Information Act request for CIA documents on U.S. newspapers.

Jack C. Landau and Tonda Rush, then of the Reporters Committee for Freedom of the Press, arranged pro bono services of Steptoe and Johnson attorney Kevin Brosch. Richard O. Cunningham and Diane L. Silberstein, of the same firm, sued the CIA for documents on U.S. newspapers. Kevin's wife, Patricia, and their kids did without Kevin while he gave weekends to the case and won the release of many documents used herein. It has taken more than five years to write this book, longer than any other nonfiction book project I have ever undertaken. It draws on many years of research and discussion that have led me to the positions I articulate here for the first time. My first debt of gratitude is to the University of California Press for supporting me in this project, despite warnings about the risk the press was undertaking and attacks on the press for publishing two earlier books of mine. In particular, I want to thank my longtime editor Naomi Schneider for her inspiration, editorial skills, and patience. Thanks also to her helpful assistant, Valerie Witte. Two other editors have also provided invaluable help: Russell Schoch and Karen Croft. I am grateful to my agent, Victoria Shoemaker, to David Peattie of BookMatters, for overseeing the book's production, to my copyeditor, Amy Smith

As I was writing this manuscript, a number of other books were published that helped me with their perspectives and documentation. Many other important books that strengthened my argument were published after mine was essentially completed. Very late in the game I was able to draw on research by peace researcher Ola Tunander and the "dual state" to reinforce my own distinction between the open politics of the public state and the deep, or covert, politics of the deep state.

Most of the book was written in the San Francisco Bay Area, where as with my previous books I profited from discussions with such friends as Daniel Ellsberg and Jonathan Marshall. But as I write in the preface, I profited also from extended periods of seclusion in Thailand and from the generosity of such new friends as Terry Kong and Thanis Kanjanaratakorn. A profound shift in my perspective ensued, which profited further from discussions with the talented and experienced monks of Wat Abhayagiri in Northern California—Ajahn Pasanno, Ajahn Amaro, and Ajahn Sudanto. Also very relevant to the development of my perspectives were the two months that, thanks to the generosity of the Lannan Foundation, I spent among the citizens of Marfa and Fort Davis in West Texas.
